

**Amendment to the Agreement
Between
American Fiber Network, Inc.
and
BellSouth Telecommunications, Inc.
d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia,
AT&T Kentucky, AT&T Louisiana, AT&T Mississippi,
AT&T North Carolina, and AT&T South Carolina
Dated March 11, 2005**


Pursuant to this Amendment, (the "Amendment"), American Fiber Network, Inc. ("CUSTOMER"), and BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, and AT&T South Carolina (hereinafter referred to "AT&T"), hereinafter referred to collectively as the "Parties", hereby agree to amend that certain Commercial Agreement between the parties dated March 11, 2005 ("Agreement") to be effective on November 1, 2008.

WHEREAS, AT&T and CUSTOMER entered into the Agreement on March 11, 2005, and;


NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby covenant and agree as follows:

1. **AT&T-9STATE** is defined as AT&T in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, and South Carolina.
2. Section 4.1.5 of Attachment 1 is hereby deleted in its entirety and replaced with the following:
 - 4.1.5 The rates for End Office Switching, Tandem Switching and Common Transport are applied based on their use in the transport of an originated or terminated call. Originated calls shall utilize these pricing elements until the terminating end office is reached for an AT&T or resale End User terminated call or until the call reaches the network of a third party on a third party terminated call.
3. The Parties agree to delete in entirety all rates associated with the USOC URECU identified as "Wholesale Access Line Platform (Coin) Usage (Flat Rate)" in Exhibit A of Attachment 1 of the Agreement and replace them with the rates set forth in Exhibit A attached hereto.
4. Except as modified herein, all of the other provisions of the Agreement, dated March 11, 2005, shall remain in full force and effect.
5. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law.
6. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
