- 12/15/10 Order Entered: The charges and credits applied by Salt River through the FAC for the period of November 1, 2009 through April 30, 2010 are approved.

- 08/30/10 Order Entered:  
 (1) A public hearing shall be held on October 12, 2010 at 10:00 a.m. at the Commission's offices.  
 (2) As the Commission's offices will be closed on September 3, 2010 in observance of a statewide furlough day and on September 6, 2010 in observance of Labor Day, Salt River shall file with the Commission by September 7, 2010 affidavit attesting to its compliance or non-compliance with the requirements of 807 KAR 5:056.  
 (3) Salt River shall publish notice of the public hearing no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service area or in trade publication or newsletter sent to all customers.  
 (4) In all other respects, the Commission's Order of August 13, 2010 remains unchanged.
- 08/17/10 Salt River Electric's Affidavit of Compliance
- 08/13/10 Order Entered:  
 (1) A public hearing shall be held on October 12, 2010 at 9:00 a.m. EDT at the Commission's office to examine the application of the Fuel Adjustment Clause of Salt River from November 1, 2009 through April 30, 2010. If no interested party files written notice of its intent to attend this hearing by October 8, 2010, the public hearing is cancelled and the matter shall be considered submitted for decision based on the evidence in the record.  
 (2) Salt River shall file no later than 21 days for the date of this Order an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.  
 (3) All documents that Salt River filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9) during the period under review are incorporated by reference into the record of this proceeding.  
 (4) Salt River shall publish notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in trade publication or newsletter going to all customers. Salt River shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2010.  
 (5) The official record of the proceeding shall be by video only.
