- (1) Southeastern is granted a Certificate of Public Convenience and Necessity.
- (2) Southeastern's proposed plan of financing with RD is accepted.
- (3) Southeastern is authorized to enter a loan agreement with RD to borrow \$3,995,000 for a 40-year period with an interest rate not to exceed 2.25.
- (4) The proceeds from the loan agreement with RD shall be used only for the purposes specified in Southeastern's application.
- (5) If surplus funds remain, Southeastern may use such surplus to construct additional plant facilities if RD approves.
- (6) Southeastern shall file a copy of the "as-built" drawings and a certified statement from the engineer that construction has been completed with in 60 days of completion.
- (7) Southeastern shall monitor the adequacies of the expanded raw water supply after construction.
- (8) Southeastern shall notify the Commission one week prior to start of construction and at the 50percent completion point.
- (9) The rates set out in the Appendix are approved for service rendered on and after the date of this Order.
- (10) Within 30 days of the date of this Order, southeastern shall file its revised tariffs.
- (11) Southeastern shall require the construction to be inspected under the supervision of a professional engineer with a Kentucky registration.
- (12) Any documents filed in the future shall reference this case number and be retained in the utility's general correspondence file.
