- (6) If no requests for hearing or objections to the report are filed with the Commission within 14 days of the filing of Commission Staff's report, this matter shall stand submitted for decision.
- (7) Prior to any hearing being held, Commission Staff shall convene an informal conference to discuss the possibility of settlement.
- (8) Copies of all documents served upon any party shall be served on all other parties and filed with the Commission.
- (9) Copies of all documents filed with the Commission shall be served upon all other parties.
- (10) Service of any document shall be made in accordance with 807 KAR 5:001, Section 3(7).
