Cumberland District's proposed plan of financing with RD is accepted. Cumberland District is authorized to issue revenue bonds in the amount of \$1,000,000 at an interest rate not to exceed 2.375 percent per annum for 40 years. 4. Cumberland District shall use the proceeds of the proposed issuance of revenue bonds only for the purposes set forth in its application. 5. Cumberland District shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 6.
