	the first five years following the deployment of the Sensus iPERL meters and shall test for accuracy
	1,000 meters of the installed Sensus iPERL meters each year of the following five years.

	statistical report that 807 KAR 5:006, Section 4(2), requires, the results of the sample meter testing
	conducted in accordance with ordering paragraph 5.
