- 1 The rate proposed in Joann Estates' Application is denied.
- 2. The rate shown in Appendix B is approved for sewer service rendered on and after February 22, 2014.
- 3. Within 20 days of the date of this Order, Joann Estates shall file revised tariff sheets with the Commission, using the Commission's electronic Tariff Filing System, containing the rates set forth in Appendix B to this Order.
- 4. As agreed in response to Staffs report, Joann Estates shall expend \$9,600 annually for sludge removal in all future reporting periods; however, this amount is prorated to \$7,200 for the year ending December 31, 2014, since Joann Estates will not begin recovery of the sludge hauling expense until April, 2014, when the rates approved by this Order become effective. Joann Estates shall report all sludge hauling expenses using account 701-C (Labor and Expense, Treatment System, Sludge Hauling) when filing its Annual Financial and Statistical Reports with the Commission and it shall attach copies of all invoices that support the amount reported. The invoices shall clearly indicate the plant or lagoon from which sludge was removed.
- 5. In all future reporting periods, Joann Estates shall depreciate its assets using the straight-line method. No retroactive adjustment to accumulated depreciation or retained earnings shall be made to account for this change in accounting method.
