Order Entered: Jackson Purchase shall submit to the Commission a written response to the allegations contained in the Staff Report within 20 days of the date of this Order. 2. Jackson Purchase shall appear on August 15, 2017, at 9:00a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violations of KRS 278.042, the 2017 edition of the NESC, and the Jackson Purchase Safety Manual, and showing cause why it should not be subject to the penalties prescribed in KRS 278.990(1) for these alleged violations. 3. The August 15, 2017 hearing shall be recorded by digital video recording only. 4. The Staff Report in the Appendix to this Order is made a part of the record in this case. 5. At the scheduled hearing in this matter, Jackson Purchase shall also present evidence on the adequacy, safety, and reasonableness of its practices related to the construction, installation, and repair of electric facilities as they relate to the facts of this case and whether such practices require revision as related to this incident. 6. Any requests for an informal conference with Commission Staff shall be set forth in writing and filed with the Commission within 20 days of the date of this Order .
