The QIP Rider of 2.04 percent is fair, just and reasonable, and is approved for service rendered on and after July 1, 2021, through June 30, 2022. 4. Beginning on March 1, 2022, Kentucky-American shall file annual QIP applications no later than March 1 for the QIP Rider that is effective July 1 of the same year. The Commission may extend the QIP proceeding beyond 120 days for good cause. 5. Within 20 days of the date of this Order, Kentucky-American shall, using the Commission's electronic Tariff Filing System, file its revised tariffs setting out the rates authorized in this Order and the revised QIP Rider and reflecting they were approved pursuant to this Order, and stating that Kentucky-American's QIP rate base in any forecasted period will be calculated in a manner consistent with 807 KAR 5:001, Section 16(6)(c). 6.
