Robbie Puckett is assessed a fine of \$500 for violation of KRS 367.4911(1)(a) for failure to provide Delta Natural Gas Company Inc., the operator of an underground facility serving the public, with notification of his intended work and work schedule not less than two nor more than ten full working days prior to commencing work and for violation of KRS 367.4917(4).
