A hearing in this matter shall be held on Wednesday, February 2, 2022, at 1 p.m. Eastern Standard Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. 2. The payment of the \$500 civil penalty without the filing of the Annual Report is rejected and will be returned to Southern Madison District by certified mail, along with a copy of this Order. 3. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
- 10/14/21 Order Entered: 1. Southern Madison District shall file with the Commission, no later than November 9, 2021, its Annual Report for the 2020 calendar year. 2. A formal hearing shall be scheduled by separate Order for the purpose of showing cause why Southern Madison District should not be subjected to the penalties of KRS 278.990 for its failure to comply with 278.230(3) and 807 KAR 5:006, Section 4.
