Re: Delay of Transfer of Control of Grasshopper Group, LLC to LogMeIn, Inc.

Dear Ms. Mathews:

On February 7, 2017, Grasshopper Group, LLC ("Grasshopper"), Citrix Systems, Inc. ("Citrix Systems" or "Transferor"), and LogMeIn, Inc. ("LogMeIn" or "Transferee") (collectively the "Parties"), notified the Commission of the consummation of the transfer of control of Grasshopper to LogMeIn ("Transaction"). The Parties are submitting this supplemental filing to clarify the timing of the transfer of control. Specifically, the Parties clarify that control of Grasshopper remains with Citrix Systems, and will not transfer to LogMeIn, until completion of certain remaining conditions.

On July 26, 2016, Citrix Systems and LogMeIn jointly announced the proposed combination of GetGo, Inc. ("GetGo"), a wholly owned subsidiary of Citrix Systems that holds the GoTo family of products, including Grasshopper, with LogMeIn in a Reverse Morris Trust transaction. On February 1, 2017, the Parties completed the merger of GetGo into a subsidiary of LogMeIn, with GetGo surviving as a wholly owned subsidiary of LogMeIn. However, the transfer of Grasshopper is subject to a transition period, during which Citrix Systems will retain control of Grasshopper. Specifically, Citrix Systems continues to hold voting and managerial control of Grasshopper. Upon receipt of regulatory approvals, voting and managerial control will transfer to GetGo, which will give LogMeIn indirect control of Grasshopper.

The transfer will be automatic, so the Parties will not conduct a separate closing. The Parties will file a subsequent consummation notice upon completion of the transfer of control to update the Commission.
