Logix Communications Corporation ("Logix") and/or American Telco, Inc. ("ATI") hereby give thirty (30) days notice to the Kentucky Public Service Commission, requesting cancellation of its Certificate of Convenience and Necessity, granting Logix and/or ATI authority to provide toll resale telecommunications services in Kentucky. Logix is currently providing long distance services to nine (9) customers in Kentucky. In order to ensure continued long distance services for these customers, Logix has entered into an agreement with Alternatel to provide long distance services to these customers, but is also informing them of their ability to choose another carrier. Pursuant to Kentucky Rules and Regulations, Logix all customers will be given thirty (30) days notice. A copy of our notice, mailed to each of our long distance customers in Kentucky, is enclosed. The notice was mailed as of this date, and notifies our customers to choose another long distance carrier.
