**Notice of Discontinuance of Common Carrier Broadband Internet Access Transmission Service Under Tariff and Continued Provision of Service on a Permissive Detariffed Basis**

**CC Docket No. 02-33**

Mountain Rural Telephone Cooperative currently offers common carrier broadband Internet access transmission service under tariff through the National Exchange Carrier Association (NECA) Tariff F.C.C. No. 5. Mountain Rural Tel. Coop. hereby provides notice that the Cooperative has requested from NECA that it remove the Cooperative as a provider of Digital Subscriber Line Access Services under Tariff F.C.C. No. 5, effective July 2, 2019.

Furthermore, Mountain Rural Tel. Coop. will continue to provide common carrier wireline broadband Internet access transmission service on a permissive detariffed basis. Mountain Rural Tel. Coop. will post the rates, terms and conditions of its broadband Internet access transmission services to its website of [www.mrtc.com](http://www.mrtc.com). The Cooperative will also make physical copies of its offering reflecting the rates, terms and conditions available for public inspection at its business office, at the address provided below:

The discontinuance of Mountain Rural Tel. Coop.'s offering of broadband Internet access transmission service under tariff, and the continued provision of such service on a detariffed basis, will apply to the entirety of the Cooperative's study area. This includes the following exchanges: Campton, Ezel, Frenchburg, Hazel Green, Jeptha, Sandy Hook, and West Liberty.

Mountain Rural Tel. Coop. currently has only one customer for its broadband Internet access transmission service. That customer is the Cooperative's own non-regulated Internet service provider (ISP) affiliate. The Cooperative's affiliated ISP purchases broadband Internet access transmission service for use as an input for the broadband Internet access services it offers to residential and business end-user customers. The discontinuance of the tariffed offering of broadband Internet access transmission service will have no effect on the end-user services provided by the Cooperative's affiliated ISP.

On April 24, 2019, Mountain Rural Tel. Coop. furnished its affiliated ISP with the attached memorandum, which notifies the ISP of the Cooperative's plan to discontinue its provisioning of broadband Internet access transmission service under tariff and to continue providing such service on a detariffed basis.

This is to notify you of a change in the way in which Mountain Rural Telephone Cooperative provides broadband Internet access transmission service, which is used as an input for the broadband Internet access services that you offer to residential and business end-user customers.

Presently, Mountain Rural Tel. Coop. provides broadband Internet access transmission service under tariff through the National Exchange Carrier Association (NECA) Tariff F.C.C. No. 5. Effective July 2, 2019, Mountain Rural Tel. Coop. will no longer offer its transmission service under the NECA tariff. Instead, the Cooperative will provide broadband Internet access transmission service on a common carrier, non-tariffed basis.

The discontinuance of Mountain Rural Tel. Coop.'s offering of broadband Internet access transmission service under tariff, and the continued provision of such service on a common carrier, non-tariffed basis, will apply to the entirety of the Cooperative's service area. This includes the following exchanges: Campton, Ezel, Frenchburg, Hazel Green, Jephtha, Sandy Hook, and West Liberty.
