NewPath Holdings, Inc. ("NewPath") submits this notice of intent to provide local exchange and interexchange telecommunications services within the Commonwealth of Kentucky. In accordance with the Kentucky Public Service Commission's orders issued in Administrative Case Nos. 359 and 370, NewPath submits the following information:

5. A notarized statement that NewPath has not provided or collected for intrastate service in Kentucky prior to filing this notice is attached as Attachment 3.

6. NewPath seeks the authority to provide operator assisted services to its customers. To the extent it provides such service, NewPath may provide service to traffic aggregators. In the event that NewPath provides service to traffic aggregators, it will comply with the Commission's mandates in Administrative Case No. 330.

7. Initially, NewPath intends to concentrate on providing data transmission services, including xDSL technology, to provide high-speed, high-quality data connections to business and residential customers. However, NewPath contemplates expanding its services in the future to include local exchange and interexchange voiceband services. Although data services have not traditionally been subject to tariffs and NewPath will not initially be offering voice services, NewPath has attached its proposed tariff as Attachment 4.
