
Pursuant to Administrative Case No. 359, please accept this letter as notification that Call Processing, Inc. is transferring control to PaySpot, Inc. ("PaySpot"). Call Processing, Inc.'s tariff was filed with the Commission effective October 21, 2000.

PaySpot will acquire control of Call Processing, Inc. through a stock purchase under which PaySpot will purchase 100% of the issued and outstanding stock of Call Processing, Inc. for common stock of PaySpot's parent company, Euronet Worldwide, Inc. The company will continue to operate as Call Processing, Inc. and only its underlying ownership will change as a result of this transaction.
