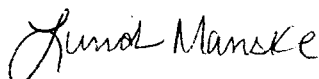
RE: Certificate of Authority Cancellation

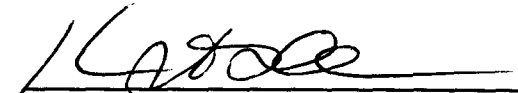
